After the initial two years, the tax rate drops to 12%. The state tax on fully automated electronic table games is currently 48%. Both rates will decline 2% on the second anniversary of the introduction of table games at that particular facility.

<sup>&</sup>lt;sup>3</sup> Non-Banking table games are those in which a player competes against another player and the casino collects a rake.

<sup>&</sup>lt;sup>4</sup> Banking table games are those in which a player competes against the casino rather than another player.

<sup>&</sup>lt;sup>5</sup> Electronic gaming tables are defined by statute and generally include a mechanical, electrical or computerized contrivance, terminal, machine or other device which is available for play or operation by one or more players as a table game.

<sup>&</sup>lt;sup>6</sup> Fully automated electronic gaming tables are electronic gaming tables that are determined to be playable or operable as a table game without the assistance or participation of a person acting on behalf of a casino.
