Gaming Control Board Reports Gaming Revenue for May

HARRISBURG, PA: The Pennsylvania Gaming Control Board reported today that the combined total revenue generated from all forms of gaming along with fantasy contests during May 2022 was \$447,794,294 an increase of 8.38% compared to revenue generated in May 2021.

Sources of gaming revenue regulated by the Pennsylvania Gaming Control Board include slot machines, table games, internet gaming, sports wagering, fantasy contests and video gaming terminals (VGTs). The following chart compiles all revenue generated in May 2022 by casinos along with fantasy contests and video gaming terminals operated by other vendors and includes a comparison to total revenue generated last May.

Retail Slot Machine Revenue

May's gross revenue from slot machines was \$205,666,269, a 2.12% increase in revenue when compared to the \$201,390,367 generated in May 2021.

The number of slot machines in operation in May 2022 was 26,004 compared to 22,496 at the casinos in May 2021.

Retail Table Games Revenue

Table games revenue for May 2022 was \$88,577,662, an increase of 14.69% from May 2021 when revenue was \$77,229,031.

Casino games offered online generated gross revenue of \$113,305,939 during May 2022 compared to \$101,251,771 in May 2021 an increase of 11.91%.

Sports Wagering Revenue

May 2022 total sports wagering handle was \$493,350,519 or 10.25% above the May 2021 total of \$447,465,027. At the same time, the taxable revenue figure for May 2022 was \$35,009,849 compared to \$27,746,484 in May 2021 an increase of 26.18%.

Tax revenue generated from sports wagering during May 2022 was \$12,603,546*.

Video Gaming Terminals

Total adjusted revenue for May 2022 for video gaming terminals (VGTs) was \$3,667,234 or 1.18% higher than May 2021 when revenue was \$3,601,864. By the close of May 2022, four VGT Terminal Operators were operating the maximum permitted five machines at 64 truck stop establishments.

Fantasy Contests

Fantasy Contests revenue was \$1,567,341 in May 2022, a decrease of 20.14% over May 2021, when revenue was \$1,962,644.

About the Pennsylvania Gaming Control Board

The Pennsylvania Gaming Control Board is tasked to oversee all aspects of gambling involving 16 land-based casinos, online casino games, retail and online sports wagering, and Video Gaming Terminals (VGTs) at qualified truck stops, along with the regulation of online fantasy sports contests.

The land-based casino industry in Pennsylvania consists of six racetrack (Category 1) casinos, five stand-alone (Category 2) casinos, two resort (Category 3) casinos and three mini-casinos (Category 4). Casino expansion will continue over the next couple of years with the anticipated openings of up to two additional Category 4 casinos. A significant job generator in the Commonwealth, casinos and the other types of Board-regulated gaming is expected to generate over \$2 billion in tax revenue during the 2021/2022 State Fiscal Year.
