Chair Smyler announced that the Board held an Executive Session on March 19<sup>th</sup> to discuss personnel matters, pending litigation and to conduct quasi-judicial deliberations relating to matters coming before the Board on March 20<sup>th</sup>.

Chair Smyler also recognized Christin Heidingsfelder's, ex-officio designee from the Department of Revenue, retirement from state service after a distinguished career and outstanding service to the Board.

#### **MINUTES/TRANSCRIPT**

On a motion by Commissioner Manzano-Díaz, seconded by Commissioner Hickernell, the Board unanimously approved the minutes and transcripts of the December 13, 2023, meeting.

On a motion by Commissioner Hickernell, seconded by Commissioner Dillon, the Board unanimously approved the minutes and transcripts of the January 24, 2024, meeting.

#### **EXECUTIVE DIRECTOR'S REPORT**

Executive Director, Kevin O'Toole, began his report by raising awareness of March being Problem Gambling Awareness Month and certain self-help steps that any player with online gaming accounts in Pennsylvania can use, in order to lessen the impacts of gambling on a player's ability to control their gaming activity and avoid problem or compulsive gambling.

To start, Kevin mentioned Section 814a.2 of Board regulations, which offers players various gaming selfimposed limits, or SIL's. Kevin explained these SIL's allow players to control the amount of their deposits, maximum amount of each wager, maximum amount of funds they want to spend while online gambling, along with a self-imposed cooling off period that has just one requirement, which is a 72 hour minimum cooling off period.

#### March 20, 2024 - BOARD MINUTES

Next, Kevin spoke about Office of Compulsive and Problem Gambling Director, Elizabeth Lanza, and her ability to monitor the usage of the SIL's, on a monthly basis through the assistance of online gaming operators who provide the statistics of the registered player accounts. He explained the most used limit that player's chose is the deposit limit, while the second most used SIL is the self-suspension cool down period. Kevin further explained during the month of January in 2024, the deposit limit was activated by players over 154,000 times and the self-suspension cool down period was activated over 78,000 times. Mr. O'Toole stated these self-imposed limits are important because they provide players with control over their gambling activity with respect to online gaming on simulated slot machines and table games.

Kevin then discussed how the Department of Drug and Alcohol Programs coordinates the statutorily required annual report on the impact of online gambling on compulsive and problem gambling, pursuant to the Gaming Act, Section 1211(d.1), which is written by a team of professors, researchers, and analysts from the Penn State University, after they complete and compile the current year's research on this topic. Kevin explained the 2023 Report on the impact of online gambling on compulsive and problem gambling, one of the more important points, was 16% of Pennsylvania adults reported they engaged in online gambling during the year. This, Kevin said, was an increase of 11% in the previous year's report.

Mr. O'Toole concluded his report to say while there are always challenges that must be met to minimize compulsive and problem gambling, they are being met in Pennsylvania by combined efforts between the Pennsylvania Council on Compulsive Gambling, the Department of Drug and Alcohol Programs, and the Pennsylvania Gaming Control Board.
