PA Gaming Control Board Reports Record Monthly Revenue in November Driven by All-Time Highs in Sports Wagering and iGaming

HARRISBURG, PA: The Pennsylvania Gaming Control Board (PGCB) reported today that the combined total revenue generated from all forms of gaming, along with fantasy contests, during November 2024 was a record \$562,368,782. The November total also was a significant increase of more than 26% compared to revenue generated in November 2023.

Sources of gaming revenue regulated by the PGCB include slot machines, table games, internet gaming, sports wagering, fantasy contests and video gaming terminals (VGTs). The PGCB has posted separate reports for these types of gaming on its website, https://gamingcontrolboard.pa.gov/.

Total tax revenue generated collectively through all forms of gaming and fantasy contests was \$232,800,147* during November 2024.

The following chart compiles all revenue generated in November 2024 by casinos, along with fantasy contests and VGTs operated by other vendors and includes a comparison to total revenue generated in November 2023.

Slot Machine Revenue

November's revenue from the play of retail slot machines was \$201,507,225, a 6.21% increase in revenue when compared to the \$189,728,426 generated in November 2023.

The number of slot machines in operation in November 2024 was 24,474 compared to 25,035 at the casinos in November 2023.

Retail Table Games revenue for November 2024 was \$77,564,017, a decrease of 2.45% from November 2023 when revenue was \$79,511,555.

Casino games offered online generated monthly gross revenue totaling \$200,490,599 during November 2024 compared to \$158,015,003 in November 2023, an increase of 26.88%.

Sports Wagering Revenue

November 2024 total sports wagering handle was a record monthly high of \$935,530,170, 0.15% above the November 2023 total of \$934,130,152.

The taxable revenue figure for November 2024 was also a record monthly amount at \$77,097,494, or 498% higher when compared to November 2023, when taxable revenue was \$12,884,034.

Tax revenue generated from sports wagering during November 2024 was \$27,755,098*.

Video Gaming Terminals

Total adjusted revenue for November 2024 for video gaming terminals (VGTs) was \$3,241,393, 4.39% lower than November 2023 when revenue was \$3,390,189. By the end of November 2024, all VGT Operators offered the maximum permitted five machines at each of the 74 qualified truck stop establishments, compared to five machines at each of the 71 establishments at this time last year.

About the Pennsylvania Gaming Control Board

The Pennsylvania Gaming Control Board is tasked to oversee all aspects of gambling involving 17 land-based casinos, online casino games, retail and online sports wagering, and Video Gaming Terminals (VGTs) at qualified truck stops, along with the regulation of online fantasy sports contests.

The land-based casino industry in Pennsylvania consists of six racetrack (Category 1) casinos, five stand-alone (Category 2) casinos, two resort (Category 3) casinos and four mini-casinos (Category 4). A significant job generator in the Commonwealth, casinos and the other types of Board-regulated gaming generated \$2.54 billion in tax revenue in Fiscal Year 2023/24.
